#### Asset Allocation Funds<sup>1</sup>

**Retirement Date Funds** - The funds seek to provide for retirement outcomes consistent with investor preferences throughout the savings and drawdown phase based on quantitatively measured risk that investors, on average, may be willing to accept. The funds will be diversified across global asset classes, with allocations changing over the investment horizon to become more heavily oriented toward debt and debt-like securities, on the premise that individuals investing for retirement desire to reduce investment risk in their retirement accounts as their retirement date approaches. The date in the name of the target date fund is the assumed date of retirement. The principal value of the fund is never guaranteed

#### Bond Funds<sup>2</sup>

**U.S. Bond Index Fund**<sup>3</sup> – The objective of the U.S. Bond Index Fund is to track the performance of the Bloomberg U.S. Aggregate Index. In meeting this objective, the Fund may invest in securities (including those issued through private placements) and a combination of other collective funds that together are designed to track the performance of the Bloomberg U.S. Aggregate Index.

#### **Fixed Investment Option**

**Stable Value Fund**<sup>4,10</sup> - The Stable Value Fund seeks to provide safety of principal (the amount you invest) and a stable yield (the income of your investment) consistent with that of high-quality intermediate bond funds.

#### International Stock Funds<sup>5</sup>

**Global Non-U.S. Stock Index Fund**<sup>6</sup> - The Fund seeks to track the performance of the MSCI All Country World Index (ACWI) ex-U.S. Index ("Index"). In meeting this objective, the assets of the Fund may be invested in securities, and a combination of other collective funds that are designed to track the performance of such Index. ### **Large Company Stock Funds**

**U.S. Large Company Stock Index Fund**<sup>6</sup> - The strategy seeks to replicate the performance and characteristics of the S&P 500® Index<sup>7</sup> with minimal tracking error. Mellon Capital uses full replication to construct the portfolio, holding each security in the index in its proportionate weight. This method limits the need for rebalancing and substantially reduces transaction costs relative to other indexing methods.

#### Mid-Sized Company Stock Funds<sup>8</sup>

**U.S. Small/Mid Company Stock Index Fund**<sup>6</sup> - The U.S. Small/Mid Company Stock Index Fund seeks to match the performance and overall characteristics of the Dow Jones U.S. Completion Total Stock Market Index<sup>™</sup> in a risk-controlled, cost-effective manner. The Funds approach to quality indexing aims to minimize tracking error, manage transaction costs, and replicate the majority of the index and sample from the remaining smaller securities.

#### **Money Market Funds**
